SECTION 1. ELIGIBILITY:

ANY WOMAN BELIEVING IN THE PHILOSOPHY OF THE REPUBLICAN PARTY AND IN THE OBJECTIVES OF THIS ORGANIZATION SHALL BE ELIGIBLE FOR MEMBERSHIP.

SECTION 2. ACTIVE MEMBER:

AN ACTIVE MEMBER IS A WOMAN WHO MEETS THE ELIGIBILITY REQUIREMENTS OF THIS ORGANIZATION AND PAYS THE ANNUAL DUES. IF A PROSPECTIVE MEMBER IS A CITIZEN OF THE UNITED STATES SHE SHALL BE A REGISTERED VOTER. SHE SHALL ENJOY THE FULL PRIVILEGES OF MEMBERSHIP.

SECTION 3. ASSOCIATE MEMBER:

AN ASSOCIATE MEMBER IS AN ACTIVE MEMBER OF ANOTHER REPUBLICAN WOMEN'S ORGANIZATION WHO WISHES TO BE A MEMBER OF THIS ORGANIZATION BY PAYING THE REQUIRED ANNUAL DUES FOR ASSOCIATE MEMBERS. THESE MEMBERS MAY ATTEND MEETINGS, BUT CANNOT MAKE MOTIONS, OR VOTE, BE ON A COMMITTEE, HOLD OFFICE, OR BE COUNTED FOR THE PURPOSE OF DETERMINING THE NUMBERS OF DELEGATES TO NATIONAL OR STATE FEDERATION MEETINGS OR CONVENTIONS. A FEMALE ASSOCIATE CAN HOWEVER, SPEAK TO A MOTION IN A BUSINESS MEETING.

A REPUBLICAN MALE MAY BECOME AN ASSOCIATE MEMBER OF THE CLUB BY PAYING THE REQUIRED ANNUAL DUES. HOWEVER, A MALE ASSOCIATE CANNOT MAKE MOTIONS, VOTE, BE ON A COMMITTEE, HOLD OFFICE OR SPEAK TO A MOTION AT A REGULAR BUSINESS MEETING.

SECTION 4. DELEGATE REPRESENTATION:

AN ACTIVE MEMBER MAY BE COUNTED IN ONE CLUB ONLY FOR THE PURPOSE OF DELEGATE REPRESENTATION TO FEDERATION STATE AND NATIONAL CONVENTIONS AND THIS WILL BE THE ONLY CLUB IN WHICH SHE MAY HOLD OFFICE. HER DUES AND NAME SHALL BE SUBMITTED TO THE TEXAS FEDERATION OF REPUBLICAN WOMEN FROM THIS CLUB ONLY.

SECTION 5. PER CAPITA DUES:

THIS ORGANIZATION AND ITS MEMBERS SHALL BE MEMBERS OF THE TEXAS FEDERATION OF REPUBLICAN WOMEN AND THE NATIONAL FEDERATION OF REPUBLICAN WOMEN, SHALL SUPPORT THEIR OBJECTIVES AND POLICIES, AND SHALL PAY PER CAPITA DUES AND THE ANNUAL SERVICE CHARGES OF SAID ORGANIZATIONS.
