VP POLICITAL ACTIVITIES



Can you believe it's 100 days until the election? We have a lot of work to do! But first let's celebrate a little. Thank you to all the clubs that worked hard and reviewed and submitted revised hours for 2021 and 2022. We blew those hours out of the world! Our final total submitted to NFRW was 1,589,339 hours for the last year! How absolutely fabulous! This is for the last year. Our 2nd quarter total is 484,419 hours. We are almost at my goal of 500,000 hours per quarter. Keep counting, tracking, and submitting!

The new item we are tracking is political calls. These are all calls you make that are for your club, campaigns, TFRW, NFRW or any of the activities that you do that are

political. You are counting the time, now we want you to count the quantity. There were 32 clubs that reported their number of calls for a total of 86,313 calls.

Congrats to everyone and, a special shout out to one of our newest clubs, Blanco County Republican Women, who submitted 7,215 hours for 2nd quarter! What a fabulous start. I expect great things from them.

Someone asked me which club had the most impressive hours. Would you believe, the one that turned in 24 hours for Q2-2022? While nothing is staggering about that amount, they actually submitted them and they were able to add to the whole.

We are an organization of more than 160 clubs and 11,000 members, so we need the input from each and every member and club to show our strength. I am going to let NFRW make the announcements of the individual members with the most hours and most political calls.

Regarding calls, we announced that we would issue Eagle Pins to VEP callers with more than 5,000 red Dialer calls. Then the decision was made by VEP to utilize a power dialer program that makes multiple calls at a time. Once one phone answers, it puts the other numbers back into a queue, but it actually credits the caller with calls for the full number of phone numbers dialed. The team decided that since the counts were not for the actual number of calls made, that we would change the quantity of calls needed to earn the pin. The power dialer does about 10 numbers each time, so we are going to award the pins at 50,000. This will be fairer for those who made the 5,000 before the power dialer was implemented. This may be adjusted if the power dialer quantities are adjusted.

Please make sure you read the article about the Adopt a Candidate project following this article. I'm so excited about this so we notified the candidates and invited them to stop by the Board Meeting. It was extra special that Rep. John Lujan HD118 and Rep. Carolyn Harris HD52 were both able to stop by and say hello. We have a lot of work to do to help get them elected. In late September and early October, TFRW will be coordinating Red Heel Brigades. These are block walks in key areas where local TFRW clubs, the County Chair, other local clubs and any volunteers from the area and outside areas gather to block walk and phone bank for local candidates. It's an effective way to cover a large area in a day or weekend. The areas we are hoping to take on are Dallas/Collin/Denton, Harris, San Antonio, West Texas, and South Texas/Rio Grande Valley area. We need local coordinators to be the onsite point of contact. Email me at vpcampaignact@tfrw.org if you are interested in helping, or want to organize one in your area. The Democrats are raising funds, registering people, getting their message out, and getting fired up. We need to make sure we stay 10 steps ahead of them. We cannot get complacent or hope they keep making stupid statements—like calling residents of San Antonio breakfast tacos. We cannot let any of our own differences divide us. We have to focus on defeating them and not attacking each other. The primaries are over and our candidates have been chosen by the Republican voters of Texas. That is who we are voting for. And, we are voting the ENTIRE ballot! No skipping candidates and stopping halfway down. Every seat is critical and we want every seat.

August is GO time! Get your game plan set for doing something every day until election day. Consider it your own 100 days of action!

Profit over safety. The COVID Vaccination is Dangerous for Children The Texas government must do whatever it takes to prevent mandated COVID vaccines for children. Under the pretense of public safety, the federal government and pharmaceutical companies are willing to sacrifice your children to make a profit. We must not continue to allow this to happen. According to government data published on the Vaccine Adverse Event Reporting System (VAERS) website, as of July 12, there have been 29,273 individuals who have died and 241,910 have had serious adverse reactions from the experimental COVID vaccines. Reporting systems in other countries show alarming results as well. EudraVigilance, the European database, shows 1,328,328 reported adverse events.

Initially we were told the vaccine would prevent, or at least decrease, the likelihood of hospitalizations and serious infection, now we know that has not been the case. Still there is no credible report indicating that ANY life has

actually been saved or anyone kept out of the hospital because they received one of the experimental vaccines. Now Pfizer wants to extend its death march to children. On June 17, 2022, the U.S. Food and Drug Administration extended the emergency use authorization of Pfizer's COVID-19 vaccine for children aged 6 months to 5 years. In spite of the fact that Pfizer's own data was manipulated to hide the injuries and deaths during trials, our government is encouraging this child vaccine. Some of the most basic concerns and questions are: *Why did only two-thirds of the 4,536 children recruited by the FDA not complete the trial? Was their data thrown out to fit a predetermined conclusion? *Why was the trial not able to show a reduction in severe illness among those vaccinated? *The FDA's own risk benefit assessment showed a 30 percent increased chance of contracting COVID-19 in children vaccinated after the first dose compared to those in the placebo group. Why was this overlooked? *Why was approval granted when the manufacturer's own trials showed zero benefit to RCRW.ORG TFRW REGION #5 SENATE DISTRICT #2 AUGUST 2022 children? *Why was authorization granted by the FDA when there is no data related to the long-term impact of the mRNA vaccine on children who are not at risk of serious illness or death, unless they are significantly immune compromised?

I agree with clinical doctors like Peter McCullough and Robert Malone who had great success treating COVID with early, preventative measures and are strongly opposed to vaccinating children. Though it is unpopular to say, deaths from the COVID vaccine are much higher than any other vaccine. According to Pfizer's own analysis, of the 42,086 total number of Pfizer vaccines that were administered in the first 90 days, there were 1,223 deaths.

In the UK, a group of 76 medics, scientists, and healthcare professionals wrote a letter urging health authorities against giving children the COVID vaccine. Many healthcare professionals are quite alarmed that this vaccine is being pandered to children without any knowledge of the long-term effects while touting dismal efficacy ratings against future infections.

In Texas alone, as of June 17, 2022, there have been 45,295 adverse reactions to the COVID vaccine that have been formally reported to VAERS. The table below shows the effect on children.

Total Adverse Events in Texas reported to VAERS 2890 120 Serious Adverse Events in Texas reported to VAERS 119 3 Adverse Events in Texas resulting in death reported to VAERS 4.

The actual number of deaths and injuries is likely much higher. According to a study conducted in 2010, it is estimated that fewer than 1 percent of vaccine adverse events are reported to VAERS. While this study was conducted pre-COVID, we have no reason to believe that any substantial improvements have been made in the reporting of adverse events. Given the low percentage of cases that are reported, it is not a stretch to consider that the total number of deaths of children under age 17 from the COVID vaccine could be as high as 400. When the swine flu was a concern a few years ago, over 40 million swine flu vaccines were administered, yet, when just fifty people died of vaccine injury, the vaccine was immediately pulled for safety reasons and no longer administered.

Not only is the Pfizer COVID vaccine the first mRNA vaccine to be widely administered to the public, it has also been done under emergency use authorization without the traditional robust and comprehensive trials to which other vaccines have been subjected. Without these long-term, comprehensive trials, there is no way to know the long-term health benefits or long-term risks of this vaccine. The crucial thing to determine is whether children are more at risk from COVID or from the COVID vaccine? The Department of State Health Services estimates that in 2020 and 2021, 84 children under age 17 in Texas had COVID listed on their death certificate. Only one percent of those listed only COVID. The remaining 99 percent of these children had one or more comorbidities contributing to their deaths.

Texas parents should be free to consult with their pediatricians and make informed decisions regarding the health of their children without any interference or persuasion from the state. However, it is clear to me that the vaccine may cause harm to more children than COVID itself.

Not only am I opposed to mandating or requiring children to receive this experimental vaccine, that may cause more injury than the virus itself, but doctors must be required to explain in detail the serious risk of the COVID vaccine and the lack of long-term data before administering it.

The Texas Medical Board (TMB) and the state Health and Human Services Commission (HHSC) should immediately launch an intense media campaign warning doctors, nurses, and parents of the risks of this experimental vaccine. Additionally, the TMB should investigate any doctor who vaccinates a child where informed consent was not given.

Instead of parroting the rhetoric from DC, I believe that Texas needs to look at the data and the science, consider the unknown, long-term impacts of this experimental vaccine, and take a stand to protect children by ensuring that parents are presented with all the known sideeffects, death rates, and unknowns so they can truly make an informed decision in the best interest of their children.

To do anything less would make the state complicit in the unnecessary deaths of innocent children *Senator Bob Hall, SD 2*
