We will be meeting on March 26th at Rosini's Vineyard from 2:00 – 4:00pm.



Prohibiting schools from requiring COVID vaccine for admission. On November 17, 2022, Governor Abbott wrote to the Texas Education Agency (TEA) and superintendents reminding them that, in Texas, parents get to choose what is best for the health and well-being of their children, and as such, school districts must accept vaccine exemptions and cannot require the COVID vaccine as a requirement for admission. We want to thank Governor Abbott for his leadership in taking steps to ensure that, despite the recent recommendation from the CDC, the questionable COVID vaccine is not going to be a requirement for enrollment in Texas schools. The Department of State Health Services (DSHS) should take note of the governor's sentiment and take steps to ensure the COVID vaccine is not added to the required Texas childhood immunizations. Also, as a public health service, DSHS should inform the public of the true risks and benefits of the experimental COVID vaccines.

This public health service should include, at a minimum, accurate information on all possible adverse reactions, including the possible long-term impacts on the immune system, an increased risk of heart, liver, and kidney diseases, unknown effects on fertility, and increased cancer risks. The TEA should use this opportunity to take positive action to remind school districts that they do not have the authority to require the COVID vaccine and that they must accept vaccine exemptions as required by law. Vaccine exemption affidavits can be easily requested through the DSHS website. After filling out the request form, the affidavits will be mailed by DSHS to the recipient. Once received, the form must be notarized before being submitted to the school or daycare facility. While the governor's actions are a good start, we must see legislation this upcoming session that will take this recommendation and make it law. No experimental, untested, or highly contentious vaccine should ever be mandated for school enrollment.

## 88th Legislative Regular Session Preview

Dear Texas House District 33 Constituents:

I sincerely hope that you and your family are enjoying the Thanksgiving and Christmas seasons. This is a time of year to give thanks and gratitude to God and to enjoy time with friends, family and loved-ones. Neely, the girls and I have a lot to be thankful for.

First, I would like to thank you all for your continued support of our campaign and family. With margins of 70% and 65% in our primary and general elections, we enjoyed comfortable victories respectively in March and November. For that I thank you all who voted to send me back to Austin. We

have accomplished a lot in 6 years, but there is still a lot of work to be done.

I would like to outline some of the most important issues that Texas faces in the coming session and over the next decade. That said, there are a lot of issues that are important to you and I want to hear from you. In no particular order or importance, the following policy issues are what will be my primary focus in the session.

#### **Budget & Fiscal Policy**

As always, the Republican-led legislature is focused on controlled spending, fiscal constraint and a balanced budget. This year we will have a record budget surplus due to inflation in sales tax in which we will debate and address important issues like Buying Down Property Taxes, Property Appraisal Reform, School Safety, Transportation, Water Infrastructure and funding much needed improvements to vital state agencies like the PUC, Texas Juvenile Justice Department and the Department of Family and Protective Services. I agree with Governor Abbott that a large portion of the surplus should be returned to Texans. I look forward to working closely with Governor Abbott, Speaker Phelan, and my House colleagues on the details of how to best deploy surplus funds to provide the greatest benefit to Texans.

#### **Border, Immigration and Crime**

As our state continues to struggle with the problems of crime, drugs and security concerns along the 1,250 mile southern border with Mexico, we must continue to remain vigilant in funding our Texas Department of Public Safety and Texas Military in defending our State from dangerous cartels, drug and human trafficking via illegal border crossings. Border Security must remain a top priority as we await help from the Federal Government; which unfortunately appears could be 2 or more years from now.

#### Economy, Business & Jobs

The Economy, Job Outlook and Business Climate are strong in Texas. We must continue to foster a predictable legislative and regulatory environment for Economic Development that promotes low taxes, capital investment and a highly-skilled workforce for job creation. Texas continues to be the leading state in the country for attracting and retaining high quality workforce talent, as well as a leader in educating top talent with Tier 1 and Tier 2 research institutions across the state.

#### Public & Higher Education

That starts with funding and supporting Public and Higher Education in Texas. I have long been an advocate for students, teachers and administrators in Texas and will continue to be a supporter for Texas Public Schools and institutions of Higher Education. This includes working towards a permanent Cost-of-Living-Adjustment for Texas' retired teachers.

#### **School Safety**

Not only is educating our students and supporting their teachers and administrators important, but it is imperative we address Mental Health and School Safety in Texas schools. We can and must do better.

Businesses invest and create jobs in communities where there are quality schools and their citizens feel safe. We must continue to back our first responders by always funding and defending them.

#### A Reliable Texas Grid

As Vice Chairman of the Texas Sunset Advisory Commission, we are working on very important issues such as the operation, administration and reliability of the Texas Electric Grid as we review the efficiency and effectiveness of the PUC and ERCOT this session. These hearings are already underway and I look forward to addressing these concerns.

#### **Champion Conservative Causes**

As conservatives, we have led the way on issues of life and individual liberties. I will continue to be 100% prolife, support the 2nd Amendment, religious liberty and the family values that make Texas the best state in the country to live in, work, start a business and raise your children.

Republican Members of the Texas House Unified Behind Dade Phelan to Serve as Speaker of the House.

Today, the members of the Texas House Republican Caucus met for the Caucus' Selection of its Endorsed Speaker Candidate for the upcoming 88th Legislative Session. #### Legislative Day Update

I hope that this update finds you all feeling blessed. We have so much to be thankful for following the November election!

We held all of our statewide offices and gained a seat in the state house and in the state senate, we are spreading the Republican philosophy and making gains in South Texas, and most importantly, the good Lord let us get up this morning. As we enter the season where many of us celebrate the birth of our Savior Jesus Christ while other of our members celebrate Hanukkah, my hope is for the gift of peace and unity for our members, their families, and their friends.

I also hope that each of you will give yourself a gift: Registration for Legislative Day! Legislative Day is on Friday, February 3rd, and it will be a day of training and presentations by an amazing cast of Republicans with extensive experience in Texas government. We recognize that Biden's inflation has impacted us all, so we are holding our registration cost at 2021 levels – Early Bird registration for Legislative Day and Luncheon will be \$85. Hotel rates at the AT&T Conference Center are \$219 per night excluding taxes and parking. This is the lowest price available in the immediate area, so you'll want to book your hotel room as soon as possible. We will be sending out the registration and hotel reservation links for Legislative Day soon.

For those who can schedule to arrive early on Thursday, February 2nd, we'd love for you to meet us at the Capitol for recognition in one of the Legislative Chambers and to get a group picture. You'll also have time to visit your local representatives. More specific details will be coming soon regarding Thursday's activities.

The 2023 Legislative Session will be fast and furious. The Regular Session begins on January 10th and runs for 140 days through May 29th. The last day to file a bill (the 60th day) is March 10th, but thousands of bills will be filed prior to the beginning of the session. Returning incumbents began filing bills on November 14th, so hundreds of bills have been filed. See Filed House Bills and Filed Senate Bills.

As an organization, TFRW primarily will follow bills relating to Education and Election Integrity. These two legislative priorities may encompass dozens of bills, so we will keep you posted about the ones we are following that are moving (to committee hearing and beyond). And, Legislative Day training will prepare you to follow these bills and as well as those in which you have a personal interest and show you how to share your opinions and feedback to committees and representatives handling those bills. So register early and join us in Austin in February 2023!

I'm excited to share my knowledge and the knowledge of our speakers with you as we continue to build strong leaders for Texas.
